



**BOROUGH OF FLORHAM PARK  
ORDINANCE #16-13**

AN ORDINANCE OF THE MAYOR AND BOROUGH COUNCIL OF THE BOROUGH OF FLORHAM PARK IN THE COUNTY OF MORRIS, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING SECTION 193 OF THE CODE OF THE BOROUGH OF FLORHAM PARK, ENTITLED “SEWERS – SCHEDULE OF SERVICE CHARGES”

WHEREAS, it is in the public interest that there be a schedule of rents, rates, fees and charges (hereinafter “Service Charges”) that is practical, equitable and uniform for each class of user throughout the water quality district served by The Florham Park Sewer Utility (hereinafter “Utility”); and

WHEREAS, the Utility deems it desirable to amend and update “The Resolution Establishing the Schedule of Service Charges of The Florham Park Sewer Authority” enacted in 1965 (hereinafter “Original Resolution”) to reflect a rational classification of users following a comprehensive review of the diversity of the sewerage system users in the Borough of Florham Park; and

WHEREAS, the schedule of rents, rates, fees and charges for residential class consisting of single-family dwelling (house or condominium on individual water services) and multiple dwelling units and apartments (two (2) or more residences on shared water service) have been reduced for calendar years 2016 as contained on Exhibit 2 attached herein to one hundred seventy-three dollars (\$173.00) for single-family dwelling and multiple dwelling units and apartments as defined in the ordinance.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Borough Council of the Borough of Florham Park, in the State of New Jersey, County of Morris, that the Original Resolution is now amended by Ordinance in its entirety as follows:

SECTION 1. Section 4 shall read as follows:

Quarterly periods for use charges as used in the Schedule of Service Charges shall be any period of three calendar months, respectively commencing on the first days of January, April, July and October.

SECTION 2. Section 5. When Charges Payable, Subsection C. shall read as follows:

Use Charges shall be due and payable quarterly, in advance within thirty (30) days after the date of the beginning of any quarterly period.

SECTION 3 - All ordinances inconsistent with this ordinance are hereby repealed to the extent of such inconsistencies.

SECTION 4 - If any article, section, subsection, paragraph, phrase or sentence of this ordinance is for any reason declared to be invalid, such declaration shall not affect the remainder of the ordinance.

SECTION 5 - This ordinance shall take effect July 1, 2016.
