



**BOROUGH OF FLORHAM PARK
ORDINANCE #16-21**

**AN ORDINANCE OF THE MAYOR AND BOROUGH
COUNCIL OF THE BOROUGH OF FLORHAM PARK, IN THE
COUNTY OF MORRIS, STATE OF NEW JERSEY, AMENDING
AND SUPPLEMENTING SECTION 14 OF CHAPTER 238 OF THE
BOROUGH CODE, ENTITLED “PARKING PROHIBITED AT ALL
TIMES ON CERTAIN STREETS”**

BE IT ORDAINED, by the Mayor and Borough Council of the Borough of Florham Park, in the County of Morris, State of New Jersey and pursuant to the provisions of N.J.S.A. 39:4-8 and N.J.S.A. 39:4-197, the street described is hereby designated as a street on which parking shall be prohibited at all times.

WHEREAS, the Municipal Engineer of the Borough of Florham Park has recommended that the following street be designated as a street on which parking shall be prohibited at all times in the interest of public safety; and

WHEREAS, the Borough Engineer, as Engineer of record, has certified the location of the street and the appropriate signage;

NOW THEREFORE, BE IT ORDAINED by the Mayor and Borough Council of the Borough of Florham Park in the County of Morris, State of New Jersey New Jersey, that the following street is hereby designated as a street on which parking shall be prohibited at all times.

Section 1 -

Name of Street	Side	Location
East Madison Avenue	Both	From Rockwood Road to Brooklake Road

Section 2 -

The effectiveness of this Ordinance is contingent on signs being erected as required by law.

Section 3 -

Unless another penalty is expressly provided by New Jersey Statute, every person convicted of a violating a provision of this ordinance or any supplement thereto shall be liable to a penalty of not more than fifty dollars (\$50.00) or imprisonment for a term not exceeding fifteen (15) days or both.

Section 4 -

All ordinances or parts of ordinances inconsistent with the provisions of this ordinance shall be repealed to the extent of such inconsistency only.

Section 5 -

Should any section, paragraph, clause or any other portion of this ordinance be adjudged by a court of competent jurisdiction to be invalid, such judgment shall not affect or impair the remainder of this ordinance.

Section 6 -

This ordinance shall take effect upon final passage and publication according to law.
