



**BOROUGH OF FLORHAM PARK  
ORDINANCE # 16-22**

**AN ORDINANCE AMENDING CHAPTER 216 OF THE REVISED GENERAL  
ORDINANCES OF THE BOROUGH OF FLORHAM PARK TO REVISE REGISTRATION  
FEES FOR THE 2017 FLORHAM PARK MUNICIPAL POOL**

WHEREAS, the Mayor and Borough Council have deemed it necessary to revise and consolidate the registration fees and payment options for the Municipal Pool;

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Borough Council of the Borough of Florham Park, in the County of Morris and State of New Jersey, as follows:

Section 1. Section 216-32, entitled Registration Fees, of Chapter 216 of the Revised General Ordinances of the Borough of Florham Park entitled “Swimming Pools,” shall be amended and revised to read in its entirety as follows:

§ 216-32. Registration fees.

The seasonal fees for the Florham Park Municipal Pool utility are as follows:

Section 2. This Ordinance allows for two separate payments to be made on April 3<sup>rd</sup>, and May 1<sup>st</sup>. All payments made after May 28, 2017, will be subject to a late fee charged a \$25.00 ( \$25.66 credit card) in addition to the membership fee.

Section 3. This Ordinance allows for payment with a credit card. Payments made by credit card will incur a 2.65% service fee charge on the total payment.

Section 4. If any section or provision of this Ordinance shall be held invalid in any Court of competent jurisdiction, the same shall not affect the other sections or provisions of this Ordinance, except so far as the section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.

Section 5. All Ordinances, or parts of Ordinances, which are inconsistent herewith are hereby repealed to the extent of such inconsistency.

Section 6. This Ordinance shall take effect immediately after final passage in the manner provided by law.
