Council Portfolio Updates:

Council President Zuckerman provided the following report:

Environmental Commission:

- The size of the footbridge is being reviewed for Spring Garden Lake
- Having a work detail at Spring Garden Lake on Saturday, May 13th from 9-1 to spread wood chips

Board of Education:

• The Board of Education passed their budget. The average increase is \$69 for the average homeowner; student body is 954

Florham Park Municipal Pool:

- Still looking for lifeguards and assistant managers; looking forward to opening at the end of May
- Reminder that after May there is a \$25.00 late fee for those who didn't register.

Councilman Germershausen provided the following report:

Morris County Board of Chosen Freeholders:

• The Freeholders adopted their budget last week; \$332.1M. The average increase to homeowner is \$18 more per year. The increase was \$1.7M. The health insurance increased by \$6M.

Historic Preservation Commission:

• Suzanne Herold gave the Cub Scouts a tour of the Little Red Schoolhouse yesterday

Councilwoman Cefolo-Pane presented the following report:

Planning Board: Not much to report; a few site plan waivers

Gazebo Committee:

- The Gazebo Committee has another meeting on Thursday. Bands are all lined up; there will be no concert on Father's Day due to historically low attendance.

Councilwoman Cefolo-Pane stated there is an Ordinance on the Agenda tonight for adoption of the PILOT for supportive housing.

Councilman Carpenter presented the following report:

Florham Park Police Department

- Police participated in a nationwide distracted driving initiative; they stopped 236 cars; 128 summonses were issued
- Block Watch captain's meeting on April 26; 42 out of 70 captains attended.; currently have 124 streets with active block watch captains.
- PD held another successful Operation Take Back; 57 pounds of drugs collected

Department of Public Works

- Working on catch basin repairs
- Grass pick-up is continuing; will switch to no biodegradable bags or branches
- Assisted with water main break
- Working on composting of leaves; that is now back in-house

Florham Park First Aid Squad

• In the process of ordering a new rig; reviewing specifications

Florham Park Fire Department

- One new recruit in the pipeline for the Fire Department
- Bill Shaw longtime resident, business owner and firefighter passed away

Department of Engineering

Borough Engineer Sgaramella reported the following:

- Regarding the pedestrian bridge at Spring Garden Lake; looking at options, i.e. fiberglass composite bridges; composite reduces deterioration and mold; will report back on prices, etc.
- Madison Avenue; consultant finishing up work over there; will be advertising bd shortly.
- Borough Hall roof; meeting with architect next week; will be advertising that bid shortly

Councilman Malone provided the following report:

Recreation:

- Stobaeus Trail is looking good; Frank and the DPW crew have cleared a lot of branches; Mike met with the school; the school might extend their path
- Recreation Committee has not met for a while; will meet to finalize the awards to be given out at the 4th of July which are the Fred Stobaeus and Lou Boyd awards
- Spring season is underway; planning for summer
- Recreation youth sports are in full swing; i.e baseball, soccer and lacrosse
- Day Camp and Teen Summer Experience all in planning stages
- Men's softball; had an injury over the weekend. Man broke his ankle in three places

ORDINANCES FOR PUBLIC HEARING:

ORDINANCE #17-11

17-11 Approving the Financial Agreement for Tax Exemption Between Florham Park Borough & Florham Park Supportive Housing LP

Councilwoman Cefolo-Pane read a summary of Ordinance # 17-11 and moved for its adoption. She stated that the Ordinance was introduced and passed on first reading at a regular meeting of the Borough Council held on April 20, 2017 as follows:

AN ORDINANCE OF THE MAYOR AND BOROUGH COUNCIL OF THE BOROUGH OF FLORHAM PARK IN THE COUNTY OF MORRIS, STATE OF NEW JERSEY APPROVING THE FINANCIAL AGREEMENT FOR TAX EXEMPTION BY AND BETWEEN THE BOROUGH OF FLORHAM PARK AND FLORHAM PARK SUPPORTIVE HOUSING LP
