ORDINANCE # 19-19**

**ESTABLISHING A WATER CONNECTION FEE  
FOR THE BOROUGH OF FLORHAM PARK**

**WHEREAS**, the Borough of Florham Park has reviewed the fees relative to water conservation with the Director of the Water Utility and have adjusted the fees; and

**WHEREAS**, the Mayor and Borough Council have reviewed and approved said fees

**NOW, THEREFORE, BE IT ORDAINED** that the Mayor and Borough Council of the Borough of Florham Park, the County of Morris, New Jersey amends and supplements the following:

**EXHIBIT: “FEES FOR SERVICES”**

**SECTION C, #7. CONNECTION FEE** (fee to pay past costs of the water system)

For each Residential Service Unit the connection shall be ONE THOUSAND SIXTY NINE AND 00/100 DOLLARS (\$1,069.00)

For each Equivalent Service Unit the connection fee shall be ONE THOUSAND SIXTY NINE AND 00/100 DOLLARS (\$1,069.00).

For each reconnected service as a result of a demolition / tear down or an alteration / addition that is greater than 50% of the original dwellings, first floor living space square footage and the existing lateral outside the right of way is utilized the reconnection fee shall be equivalent to 50 % of the new connection fee.

For all user’s classes other than residential and institutional service, an Equivalent Service Unit shall computed using the tables provided by NJAC 7:10-12.6 Table 1 and NJAC 5:21-5.2 Table 5.1

A Residential Service Unit is 300 gallons per day.

The connection fee shall also apply in the case of any expansion or alteration of any existing building(s), for user classes other than residential and institutional Service.

The minimum water connection fee is one equivalent service unit.

A copy of the calculation is attached hereto and made a part hereof as set forth herein at length.

A copy of Exhibit as revised is attached hereto and made a part hereof as if set.

SECTION 1. Chapter 244, Article VI, Subsection 44 is here by supplemented by adding a new subsection to reflect the following changes in fees to be paid to the Borough of Florham Park:

SECTION 2. Unless another penalty is provided by New Jersey statute, every person convicted of a violation of a provision of this Ordinance or any supplement thereto shall be liable to a penalty.

SECTION 3. To the extent this Ordinance shall repeal, alter, amend any section of the Borough Code, the language of this Ordinance shall be controlling and in full force and effect.

SECTION 4. This Ordinance shall take effect in accordance with law.
