ORDINANCE # 19-2

AN ORDINANCE AMENDING CHAPTER 216 OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF FLORHAM PARK TO REVISE REGISTRATION FEES FOR THE 2019 FLORHAM PARK MUNICIPAL POOL

WHEREAS, the Mayor and Borough Council have deemed it necessary to revise and consolidate the fees and payment options for the Municipal Pool;

NOW, THEREFORE, BE [T ORDAINED, by the Mayor and Borough Council of the Borough of Florham Park, in the County of Morris and State of New Jersey, as follows:

Section I. Section 216-32, entitled Registration Fees, of Chapter 216 of the Revised General Ordinances of the Borough of Florham Park entitled "Swimming Pools," shall be amended and revised to read in its entirety as follows:

Section 2. This Ordinance allows for two separate payments to be made on April 8th and May 1st. All payments made after May 31, 2019, will be subject to fee schedule as indicated above.

Section 3. This Ordinance allows for payment with a credit card. Payments made by credit card will be the same price as cash/check payment.

Section 4. If any section or provision of this Ordinance shall be held invalid in any Court of competent jurisdiction, the same shall not affect the other sections or provisions of this Ordinance, except so far as the section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.

Section 5. All Ordinances, or parts of Ordinances, which are inconsistent herewith are hereby repealed to the extent of such inconsistency.

Section 6. This Ordinance shall take effect immediately after final passage in the manner provided by law.
