ORDINANCE # 18-13**

**AN ORDINANCE OF THE MAYOR AND BOROUGH COUNCIL OF THE BOROUGH OF  
FLORHAM PARK IN THE COUNTY OF MORRIS, STATE OF NEW JERSEY, TO  
ACCEPT A DONATION OF REAL PROPERTY**

WHEREAS, the Borough has received a request from Four Thirty Seven Properties LLC, owner of property known and designated as Block 1003, Lots 1 through 4, to donate such property to the Borough for public purposes; and

WHEREAS, the Borough Tax Assessment records reflect that the properties also bear the following street addresses:

Block 1003, Lot 1, 100 Columbia Turnpike  
Block 1003, Lot 2, 96 Columbia Turnpike  
Block 1003, Lot 3, 92 Columbia Turnpike  
Block 1003, Lot 4, 88 Columbia Turnpike, and

WHEREAS, NJSA 40A:12-5(a) (1) authorizes New Jersey municipalities to accept donations of real property; and

WHEREAS, the Borough Council and the Borough Engineering Department have reviewed the subject property and the Borough is desirous of accepting the proffered donatio.

NOW, THEREFORE, BE IT ORDAINED by the Borough Council of the Borough of Florham Park, County of Morris, State of New Jersey, as follows:

**SECTION 1.** The Borough of Florham Park hereby ACCEPTS the donation of real property known and designated as Block 1003, Lots 1 through 4, to be used for public purposes.

**SECTION 2.** The real property to be donated shall be valued at its current tax assessment of One Million Three Hundred Thirty Thousand Two Hundred And 00/100 Dollars (\$1,330,200.00).

**SECTION 3.** The Mayor and Borough Clerk are authorized to execute all such documents and instruments necessary to effectuate the aforesaid donation, and Borough Counsel is authorized to record any instruments appropriate for recording this transaction.

SECTION 4. All ordinances inconsistent with this ordinance are hereby repealed to the extent of such inconsistencies.

SECTION 5. If any article, section, subsection, paragraph, phrase or sentence of this ordinance is for any reason declared to be invalid, such declaration shall not affect the remainder of the ordinance.

SECTION 6. This ordinance shall take effect upon final publication as provided for by law.
