

BOROUGH OF FLORHAM PARK COUNTY OF MORRIS, STATE OF NEW JERSEY ORDINANCE # 20-11

AN ORDINANCE OF THE MAYOR AND BOROUGH COUNCIL OF THE BOROUGH OF FLORHAM PARK IN THE COUNTY OF MORRIS, STATE OF NEW JERSEY, AMENDING SECTION 216-32 "REGISTRATION FEES" OF THE BOROUGH CODE

WHEREAS, in light of the public emergency that necessitated a delay in the opening of the municipal pool and that resulted in a reduction of the total number of pool days for the 2020 season, the Mayor and Council of the Borough of Florham Park deem it appropriate to amend the Borough Code with respect to fees charged for use of the Borough swimming pool;

NOW, THEREFORE, BE IT ORDAINED by the Borough Council of the Borough of Florham Park, County of Morris, State of New Jersey, as follows:

SECTION 1. Chapter 216, Swimming Pools, Article III., Swimming Pool Utility, § 216-32, Registration Fees, of the Florham Park Borough Code is hereby amended and supplemented as follows:

A. The seasonal fees for the Florham Park Municipal Pool utility are as follows:

(An active/senior member in good standing and their immediate families with children under the age of 23)

Swim Team Membership	\$72; non-pool member: \$216
(If permissible to have Swim Team this season)	
Florham Park Life Guards Individual Pool Membership	\$25
Nonresident Family	\$432
(A husband and/or wife and/or domestic partner and all children permanently residing in the same household who are under the age of 23 and are fully dependent on the head of the household for their support and maintenance)	
Nonresident Individual (18+)	\$252
Nonresident Couple	\$360
Nonresident Senior	\$108
Nanny/Au Pair	\$126

B. All registration fees must be paid in full at the time of registration.

SECTION 2. Chapter 216, Swimming Pools, Article III., Swimming Pool Utility, § 216-33, Guest passbooks, of the Florham Park Borough Code is hereby amended to remove and delete Subsection A.

SECTION 3. Severability. Each section, subsection, sentence, clause and phrase of this Ordinance is declared to be an independent section, subsection, sentence, clause and phrase. If

any portion of this Ordinance, or its application to any person or circumstances, shall be adjudged or otherwise determined to be invalid, unconstitutional, void, or ineffective for any clause or reason, such determination shall not affect the remaining provisions of this Ordinance, and the application of such remaining provisions shall not be affected thereby and shall remain in full force and effect, and to this end, the provisions of this Ordinance are severable.

SECTION 4. Repealer. All ordinances or parts of ordinances contrary to or inconsistent with the provisions of this section are hereby repealed to the extent of such conflict or inconsistency.

SECTION 5. Prior actions. All actions of the Borough of Florham Park taken prior to the date of adoption hereof contemplated by this Ordinance are hereby ratified and approved.

SECTION 6. Effective Date. This Ordinance shall take effect immediately upon final passage and publication according to law.
