ORDINANCE # 21-14**

**AN ORDINANCE OF THE MAYOR AND BOROUGH COUNCIL OF THE
BOROUGH OF FLORHAM PARK, IN THE COUNTY OF MORRIS, STATE OF NEW
JERSEY, AMENDING AND SUPPLEMENTING SECTION 14 OF CHAPTER 238 OF
THE BOROUGH CODE, ENTITLED “PARKING PROHIBITED AT ALL TIMES ON
CERTAIN STREETS”**

WHEREAS, the Mayor and Council of the Borough of Florham Park are empowered pursuant to the provisions of N.J.S.A. 39:4-8 and N.J.S.A. 39:4-197, to regulate parking within the Borough; and

WHEREAS, the Municipal Engineer of the Borough of Florham Park has recommended that the following street be designated as a street on which parking shall be prohibited at all times in the interest of public safety; and

WHEREAS, the Borough Engineer, as Engineer of record, has certified the location of the street and the appropriate signage;

NOW THEREFORE, BE IT ORDAINED by the Mayor and Borough Council of the Borough of Florham Park, County of Morris, State of New Jersey New Jersey as follows:

Section 1. Chapter 238, “Vehicles and Traffic”, § 238-14, “Parking Prohibited at all times on certain streets”, of the Revised General Ordinances of the Borough of Florham Park is hereby amended and supplemented to add the following street as a street on which parking shall be prohibited at all times:

Name of Street	Side	Location
Park Street	West	From Intersection with Hearthwood Road to 500 feet northwest along Park Street

Section 2. The effectiveness of this Ordinance is contingent on signs being erected as required by law.

Section 3. Repealer. All ordinances or parts of ordinances contrary to or inconsistent with the

provisions of this Ordinance are hereby repealed to the extent of such conflict or inconsistency.

Section 4. Severability. Each section, subsection, paragraph, sentence, clause and phrase of this Ordinance is declared to be an independent section, subsection, sentence, clause and phrase. If any portion of this Ordinance, or its application to any person or circumstances, shall be adjudged or otherwise determined to be invalid, unconstitutional, preempted, void, or ineffective for any clause or reason, such determination shall not affect the remaining provisions of this Ordinance, and the application of such remaining provisions shall not be affected thereby and shall remain in full force and effect, and to this end, the provisions of this Ordinance are severable.

Section 5. Effective Date. This Ordinance shall take effect immediately upon final passage and publication according to law.

Section 6. Prior actions. All actions of the Borough of Florham Park taken prior to the date of adoption hereof contemplated by this Ordinance are hereby ratified and approved.

Section 7. Codification. This Ordinance may be renumbered for codification purposes.
