ORDINANCE #21-17**

AN ORDINANCE AMENDING ORDINANCE #21-11 ADOPTED MAY 20, 2021 AND ENTITLED, “AN ORDINANCE TO PROVIDE FOR GENERAL CAPITAL PROJECTS ENUMERATED WITHIN FOR THE BOROUGH OF FLORHAM PARK, COUNTY OF MORRIS AND TO PROVIDE FOR THE FUNDING THEREOF” TO INCREASE THE AMOUNTS LISTED THEREIN TO REFLECT FUNDS RECEIVED FROM THE COUNTY OF MORRIS

WHEREAS, on May 20, 2021 the Governing Body of the Borough of Florham Park (the “Borough”), in the County of Morris (the “County”) adopted ordinance #21-11 and entitled, “AN ORDINANCE TO PROVIDE FOR GENERAL CAPITAL PROJECTS ENUMERATED WITHIN FOR THE BOROUGH OF FLORHAM PARK, COUNTY OF MORRIS AND TO PROVIDE FOR THE FUNDING THEREOF” (“Ordinance #21-11”); and

WHEREAS, the Borough desires to amend Ordinance #21-11 to increase the amounts listed therein to reflect the \$305,221.25 to be received from the County pursuant to an agreement between the Borough and the County entitled, “AN AGREEMENT BY AND BETWEEN THE BOROUGH OF FLORHAM PARK AND THE COUNTY OF MORRIS, PROVIDING FOR THE AUTHORIZATION OF A PROJECT ENTITLED, “TRAFFIC SIGNAL IMPROVEMENTS RIDGEDALE AVENUE (CR608) AND BRIARWOOD ROAD”” (the “Agreement”) which Agreement was authorized by resolution adopted on May 20, 2021.

BE IT ORDAINED by the Governing Body of the Borough that the following section of Ordinance #21-11 shall be amended in its entirety to read as follows:

“BE IT FURTHER ORDAINED that the financing for the above projects be as follows:

General Capital Improvement Fund..... \$2,950,000.00

Open Space Capital Improvement Fund.....\$9,275.00
Morris County Interlocal.....\$305,221.25”

BE IT FURTHER ORDAINED that the remainder of the ordinance remains unchanged.

BE IT FURTHER ORDAINED that the capital budget or temporary capital budget of the Borough is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith and the resolutions promulgated by the Local Finance Board showing all detail of the amended capital budget or temporary capital budget and capital program as approved by the Director, Division of Local Government Services, are on file with the Borough Clerk and are available for public inspection.

BE IT FURTHER ORDAINED that the period of usefulness of the capital projects are in excess of the five (5) year statutory requirement, and that no debt shall be incurred by the Borough for this authorization.
