**AN ORDINANCE OF THE MAYOR AND BOROUGH COUNCIL OF THE
BOROUGH OF FLORHAM PARK IN THE COUNTY OF MORRIS,
STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING
CHAPTER 46 OF THE CODE OF THE BOROUGH OF FLORHAM PARK
ENTITLED “POLICE DEPARTMENT”**

WHEREAS, Chapter 46 of the Revised General Code of the Borough of Florham Park entitled Police Department was adopted in 1998, repealing a former Ordinance, Chapter 46, Police Department, adopted in 1969; and

WHEREAS, the Borough has recommended changes to the rates of pay for third-party assignments for Police Officers of the Borough of Florham Park Police Department; and

WHEREAS, the Borough of Florham Park adopted Ordinance #12-17 amending and supplementing Chapter 46 of the Code of Borough of Florham Park entitled “Police Department” at a Public Hearing held on December 13, 2012; and

WHEREAS, Chapter 46 of the Code of Borough of Florham Park entitled “Police Department” at Section 46-8, subsection D, part 1, provides for the rates of pay for third-party assignments for Police Officers of the Borough of Florham Park Police Department; and

WHEREAS, the Borough seeks to update the rates of pay for third-party assignments for Police Officers of the Borough of Florham Park Police Department.

IT IS HEREBY ORDAINED by the Borough Council of the Borough of Florham Park, Morris County, State of New Jersey, as follows:

SECTION 1. The provisions contained within Chapter 46, entitled “Police Department”, Section 46-8, entitled “Third-party assignments”, subsection D, entitled “Rate of pay; payment”, part 1 is hereby amended and replaced in its entirety by a new part that shall read in its entirety as follows:

(1) For third-party assignments:

(a) the police officer performing the third-party assignment shall be paid by the Borough at the gross hourly rate of eighty-five dollars (\$85.00) per hour with a four (4) hour minimum for all assignments. Once the officer works the four (4) hour minimum, the officer will be paid the full payment for the scheduled hours. Any hours work past the scheduled end time will be paid on an hourly basis. The police officer will also be paid the four (4) hour minimum for all jobs that are canceled less than three (3) hours prior to the scheduled start time of the job.

(b) services rendered at ADP, 71 Hanover Road, on a Monday-Friday basis from 1600 hours-1800 hours will be paid to the officer at a flat rate of Three Hundred Twenty Dollars (\$320.00). Any adjustment of this schedule will revert to the rate specified in section A.

(c) services rendered at Sun Valley from 1430 hours-1830 hours will be paid to the officer at a flat rate of Three Hundred Five Dollars (\$305.00). Any adjustment of this schedule will revert to the rate specified in section A.

SECTION 2. All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed to the extent of such inconsistencies.

SECTION 3. If any article, section, subsection, paragraph, phrase or sentence of this ordinance is for any reason declared to be unconstitutional or invalid, said article, section, subsection, paragraph, phrase or sentence shall be deemed separable, and such declaration shall not affect the remainder of the ordinance.

SECTION 4. This ordinance shall take effect upon final publication as provided for by law.
