#### **Council President Malone:**

# Finance Committee:

The 2023 Budget books will be distributed to the Borough Council by February 1. The planned introduction of the 2023 Budget is for the March 16, 2023 Borough Council meeting and public hearing and adoption will be scheduled for the April 20, 2023 Borough Council meeting.

There will be a Spring Auction in May to sell some old and obsolete trucks and equipment.

Council President Malone recognized the Florham Park-East Hanover Falcons for fundraising efforts for Buffalo Bills safety Damar Hamlin's charity.

# **Engineering:**

Columbia Turnpike/Park Street Intersection Improvement Project – Waiting for service wire to be removed

Elm Street Road and Drainage Improvement Project – Work will commence in the spring of 2023. They received a New Jersey Department of Transportation (NJDOT) grant in the amount of \$411,700.00.

The Engineering department is working on the plans and specifications for the Dellwood, Puddingstone and Rustic sidewalk and re-pavement project. They are looking to submit to NJDOT for approval in early 2023 for spring/summer construction. They have applied to NJDOT for a construction grant in the amount of \$226,000.00.

#### Police Department:

Lieutenant D'Alessio is retiring on April 1, 2023.

Dispatcher Colette Murphy will be resigning her full-time position in the near future and staying on as a part-time dispatcher. The new dispatcher is currently per diem and being trained to be the full-time replacement.

The State passed legislation required schools to perform behavioral threat assessments on students and staff involved in any school-related threat. There is an increase in Police presence at the schools as of late but this is an unfunded mandate.

# **Department of Public Works:**

Approximately \$31,688.00 has been saved by using the compact cards at the Environmental Center despite the increase in cost.

The new dump truck will be delivered in April. A total of 50 trees were removed by the Department in 2022, which does not include any trees removed by contractors.

New trucks were ordered for the Roads department.

Reorganization meetings were held and several applications have been received already.

# 4th of July Committee:

They are looking at fundraising events and volunteer outreach and the theme should be finalized in the next few weeks.

# **Building:**

Construction Official Kevin Guifoyle shared that 80 permits were issued in December and 1,226 issued all year. There were 411 inspections in December and about 7,254 for the entire year of 2022.

The Del Webb project is wrapping up. LCS (Delaney at the Green) will be complete in April or May. Palmont at Florham Park is in the framing stage.

### Library:

There are a lot of events being planned for 2023 and foot traffic is up twenty-percent.

### Water:

Well Rehabilitation Project – Water department is continuing training for Well #5 operation. The SCADA installation and testing is complete. The chlorine line was replaced with a stainless steel line by the contractor.

Well Transmission Project – The project is complete.

Water Meter replacement project - There are approximately 72 residents remaining that need their water meter replaced. Meter replacement fines will go out with the next water bill.

Water Tank Rehabilitation Design Project - No update

Florham Park Pool – Awaiting warmer days to empty the pool, clean the hydrostatic valves and pressure test the main drain.

## Sewer:

Sewer Plant Flood Hazard Area and Wetland Permit applications have been submitted to New Jersey Department of Environmental Protection (NJDEP). The Flood Hazard Area Verification has been received from NJDEP and we are waiting on wetland delineation.

Colliers Engineers continues with generator, bar screen, and clarifier designs.

Beechwood/Elmwood Cured-In-Place Lining Project - CDM completed the project specifications and it should be ready for bid in early to mid-2023 after the 2023 Budget is adopted.
