Florham Park Rehabilitation and Healthcare Center 190 Park Avenue Block 1201, Lot 3 Applicant is seeking approval for the continuation of an assisted living and long-term care facility containing 101 beds.

Michael Vitiello, Esq. represented the applicant. Tom Kilcourse, Executive Vice President of Plant Operations for Marquis Services, was sworn in.

This is a change in ownership of a long-term care facility. It will reopen in three stages. The first stage is the skilled nursing facility. This building is being refreshed and updated. The next phase would be the rehabilitation portion of the facility. The area will be expanded and feature a 5,700 square foot gym. It is for use by resident patients only. They expect this time line to be 7-8 months due to permitting by the DCA and the Borough Construction department. The final phase would be the assisted living facility. This will be open once the skilled nursing portion is filled and operating. There is only a small number of assisted living beds that will be spread among the three floors.

Florham Park has a number of assisted living facilities so there is competition in the area. The deliveries will be the same as the previous owner and all conditions from the former resolution will continue to apply. There are Medicaid beds that will be reported and will count towards the affordable housing mandate.

They will make the lobby/welcome area larger and relocate the office spaces.

Mike Sgaramella asked about the gym and the signage. Mr. Kilcourse responded that the gym area is currently quite small. They will expand this into the former chapel area. The signage will be the same size as it currently is. They will add the "Terraces" to the signage. They confirmed that this is a "for profit" entity.

Three floors will be active. There are 80 skilled nursing beds and 21 assisted living beds. The goal is to get good occupancy on the skilled nursing beds before filling the assisted living beds. The 4th floor is storage and the 5th floor is vacant space.

There is a large multi-purpose space that will temporarily serve as the rehabilitation area while they are retrofitting the new space. They must adhere to the Department of Health regulations. The rehabilitation facility is available to all residents of the facility.

Gary Feith asked about medical waste. They will only generate a small amount that will be removed by a medical waste company.

Upon questioning by Mark Taylor, they will contract with a third party vendor for ambulance service.

There will be up to 65 employees. There are three 8-hour shifts. Staff includes registered nurses and LPNs. The staffing would be based on population. Most patients do not drive. They will provide transportation on-site for residents that have doctor appointments etc.

They confirmed that there would be no memory care offered. The rehabilitation facility is a large portion of the business. It is not an out-patient facility. Rehabilitation services are only offered for persons who are staying in the facility. The facility is secure.

The meeting was opened to the public. There were no questions or comments.

Mr. DeAngelis asked for a motion.

Mr. Guerin made a motion to approve the application, second by Ms. Santoro Roll: On a roll call vote all members present and eligible voted to approve the application.

On a motion duly made and seconded the meeting was adjourned at 7:05pm.
