Zoning Board of Adjustment 2023 Annual Report

Board member Jeffrey Noss, who is also vice-chairman of the Board of Adjustment stated that the majority of variance applications are approved, however, most undergo revisions and modifications to the original plan in an effort to minimize the variances that are requested. This process usually takes two meetings for an application to be completed and ready for a vote.

Many of the variance requests are for outdoor living space improvements. The Board remains very sensitive to excess lot coverage due to soggy conditions in many parts of the Borough.

Board Secretary Marlene Rawson stated that she is working with the Zoning Officer and compiling a list of minor tweaks to the Zoning Ordinance in an effort to avoid a variance condition for insignificant requests. This list would be reviewed by the Planner.

Mike DeAngelis added that the permitted building coverage percentage is low compared to other municipalities.

Extension of Approval:

5. Sisters of Charity of St. Elizabeth

Applicant is seeking approval for a third extension of time to record the minor subdivision.

Thomas Carroll, Esq. represented the Sisters of Charity. He stated that due to ongoing sewer litigation, a TWA cannot be issued. He believes that they are close to a resolution.

Mayor Taylor said that both Florham Park and Morris Township have approved settlement resolutions.

There was a question on when the one-year extension would actually begin. It was clarified that the previous extension expired on February 16, 2024. This would be the third extension of time. If approved, the expiration date would be February 16, 2025.

Mr. Carroll gave a general update on the status. The settlement agreement would signed in March. A shared services agreement must be drafted and adopted by ordinance between Florham Park and Morris Township. He anticipates this timeframe to be late April.

The buyer would have to close on the sale of the property and then record the subdivision.

There were no other questions. Mr. DeAngelis called for a motion.

Mr. Guerin made a motion to approve the extension to February 16, 2025, second by Ms. Santoro Roll: On a roll call vote all members present and eligible voted to approve the extension.

Sid Dvorkin asked if there were any updates on the Alfieri plan. Mayor Taylor said there is nothing to report. Board Secretary responded that they still have issues to resolve with the DEP and the airport.
